STUDENTS ARE TRAINED IN THE GENRES OF JAZZ, CLASSICAL AND RHYTHM AND BLUES. STUDENTS RECEIVE: WEEKLY PRIVATE LESSONS ON 1-3 INSTRUMENTS, INCLUDING VOICE LESSONS; WEEKLY REHEARSAL FOR THE CHORUS, THE ORCHESTRA AND THE JAZZ BIG BAND.
